Points to be noted while attending Zoom live lectures :

1. Please download the zoom app on your mobile/tablet/laptop/computer.

2. Please sign-in into zoom using your email address. This is required as we shall permit entry only to registered users so as to prevent outsiders entering the meeting automatically.

3. Your name in zoom should be your student ID followed by your name. In case your name is Ram Kapoor and your students ID is J00001, then your meeting name should be J00001 Ram. This is because we shall take attendance based on that and in case we find anyone who has not kept the name as suggested above, we shall remove them from the lecture as it will imply that the person is an outsider.

4. Students should compulsorily keep their video on throughout the lectures. In case we find any student keeping the video off (in spite of having a video enabled device) we shall remove them from lectures.

5. All students are given Hard Copy of the text book. In case you have not collected, please collect it from your nearest branch. For your reference, we have also provided in the timetable a link to the soft copy of the chapters which are being taught to you.
