These lectures will be available on our online portal of www.stream.jkshahclasses.com. The login ID will be your registered mobile number and there will be an option for setting a password.

You will also get lecture index - subject wise and chapter wise (it will not be day wise) for your easy reference every week for the uploaded lectures.

All students are advised not to miss any of the live sessions and attend all lectures regularly.

Points to be noted while attending Zoom live lectures :

1. Please download the zoom app on your mobile/tablet/laptop/computer.
2. Please sign-in into zoom using your email address. This is required as we shall permit entry only to registered users so as to prevent outsiders entering the meeting automatically.
3. Your name in zoom should be your student ID followed by your name.
In case your name is Ram Kapoor and your students ID is J00001, then your meeting name should be J00001 Ram. This is because we shall take attendance based on that and in case we find anyone who has not kept the name as suggested above, we shall remove them from the lecture as it will imply that the person is an outsider.
4. Students should compulsorily keep their video on throughout the lectures. In case we find any student keeping the video off (in spite of having a video enabled device) we shall remove them from lectures.
5. For your reference, we have also provided in the timetable a link to the soft copy of the JKSC Text Book Subject-wise.
